There is no provision for registration with superfine after closing of registration with fine.

<u>Note:</u> The candidates should ensure their eligibility for improvement of internal examination after verifying the University Orders referred above.

# **Details of Fee**

- 1. Application fee: Rs. 50/-
- 2. Registration fee: Rs. 700/- per paper to the University and Rs. 1280/- to the college.
- 3. Mark list/ Grade Card fee: Rs. 55/- per semester

# **Instructions to Candidates:**

- 1. Students shall be allowed one chance per subject/ paper for improving internal assessment marks.
- 2. Re-doing of internals for improvement of marks shall be permitted only after completion of the course. No re-doing shall be allowed in any subject during the course period.
- 3. The following categories of students are not eligible for improvement of internal assessment marks:

- a) Students who have successfully completed the course.
- b) Students who have secured 60% or more marks for internal assessment in the subject/ paper concerned.
  - c) Students who have passed the subject / paper concerned.
  - d) Students who have already availed the benefit of internal improvement
- 4. Application for redoing of internal assessment marks obtained in a subject / paper shall be made within one year from the date of written examination in the last subject in the final semester of the course concerned.
- 5. Eligibility for improvement of internal marks shall generally be limited to one paper for every semester. If any student has not availed the benefit in a paper in any semester, the eligibility for the same may be carried forward to any paper in any other semester, subject to a maximum of ten papers in 5-year course and six papers in 3-year course.
- 6. Only one chance shall be allowed for re-doing internals for improvement of internal marks for a student in a particular subject / paper. If the candidate is eligible for re-doing internals for more than one paper / subject and if he desires to do so, a single application should be made for all the papers.
- 7. Internal re-do for all the papers / subjects should be done at a stretch. No further chance for improvement will be permitted.
- 8. Candidate should remit the prescribed fee for all the papers / subjects for which he desires to redo internals at a single instance.
- 9. The candidates are directed to register through the Students Portal and to follow the post payment system while remitting the examination fee.
